What is pm Suryodaya Yojana 2024?

On the auspicious day of Lord Ram's consecration ceremony at the Ayodhya Temple on January 22,2024,Prime Minister Mr. Narendra Modi announced PM Suryodaya Yojana 2024. The scheme was later renamed to PM Surya Ghar: Muft Bijli Yojanaand launched on February 13,2024,with a total allocation of Rs. 75,021 crore (~US\$9 billion).

What is pm Surya Ghar muft Bijli Yojana?

The Government of India has approved the PM Surya Ghar: Muft Bijli Yojana on 29th February, 2024 to increase the share of solar rooftop capacity and empower residential households to generate their own electricity. The scheme has an outlay of Rs 75,021 crore and is to be implemented till FY 2026-27.

What Yojana will be provided in budget 2024-25?

The Budget 2024-25 emphasised this yojana and provided that the government will provide for the installment of solar panels to 1 crore households. It will provide subsidies for installing rooftop solar panels for residential houses and using solar energy for electricity, which will help save money on electricity bills.

What is rooftop solar Yojana?

The Rooftop Solar Yojana, or the PM Surya Ghar Muft Bijli Yojana, aims to provide 300 units of free electricity every month to light up one crore households. The objective of this scheme is to reduce the electricity costs of the house by installing rooftop solar panels and using solar energy.
