How many solar panels can a New Zealand solar farm produce?

In 1994, Japan sought an increase in its allotment of bluefin tuna. Australia and New Zealand denied the request, and Japan later instituted a unilateral program in which Japan allowed fishermen to fish for bluefin tuna in excess of the SBT Convention's quotas. Australia and New Zealand invoked the compulsory arbitration provisions of UNCLOS.
