

How to deal with solar PV waste material?

Therefore, the methods of dealing with solar PV waste material, principally by recycling, need to be established by 2040. By recycling solar PV panels EOL and reusing them to make new solar panels, the actual number of waste (i.e., not recycled panels) could be considerably reduced.

How much solar PV waste will be recycled by 2050?

The worldwide solar PV waste is estimated to reach around 78 million tonnes by 2050. The current status of the EOL PV panels are systematically reviewed and discussed. Policy formation involving manufacturer's liability to inspire recycling of waste solar panels. R&D needs acceleration allowing researchers to resolve issues in PV module recycling.

Are solar PV modules a waste?

As early as 2012, the latest revision of the EU Waste Electrical and Electronic Products Management Regulations took the lead in bringing solar PV modules into the scope of management. Solar cells are officially classified as electronic waste and require efficient recycling [24,25].

What is the recycling process for silicon-based PV panels?

In this review article, the complete recycling process is systematically summarized into two main sections: disassembly and delamination treatment for silicon-based PV panels, involving physical, thermal, and chemical treatment, and the retrieval of valuable metals (silicon, silver, copper, tin, etc.).

India recycling regulations: As of now, India lacks specific rules and regulations dedicated to the management of photovoltaic (PV) panel waste, and it is currently treated under general waste regulations (Preet et al., 2023).

How big is solar PV waste?

Global installed PV capacity reached around 400 GW at the end of 2017 and is expected to rise further to 4500 GW by 2050. Considering an average panel lifetime of 25 years, the worldwide solar PV waste is anticipated to reach between 4%-14% of total generation capacity by 2030 and rise to over 80% (around 78 million tonnes) by 2050.
