The Group has signed deals for the sale of its stake in Ethos Energy Group Limited ('EthosEnergy'), a joint venture focused on rotating equipment, and CEC Controls Company Inc ('CEC Controls'), an industrial and process control systems business, in the automotive market.

Who owns EthosEnergy?

EthosEnergy is part of Wood's Investment Services business unit. Wood has entered into an agreement to sell its equity in CEC Controls and its affiliated entity in Mexico to SCIO Automation Group, for a cash consideration of \$30 million.

How much money will EthosEnergy make from wood?

Wood expects net cash proceeds of around \$125 million from these disposals when they complete, which is expected to be later in 2024. In addition, Wood will be issued loan notes by EthosEnergy which, on repayment around five years after completion, will generate further proceeds of up to \$42 million plus interest.
