

## **Exporting photovoltaic inverters to Europe**

How much do solar and energy storage inverters export?

The cumulative export amount of domestic solar and energy storage inverters reached \$8.25 billion,marking a 39% year-on-year increase. - During the same period,the cumulative export volume of domestic solar and energy storage inverters was 40.92 million units,reflecting a 24% year-on-year increase.

#### Which countries export solar panels in the EU?

The largest extra-EU export destination for wind turbines was the United Kingdom (30%), followed by the United States (18%). China (98%) was by far the largest partner for extra-EU imports of solar panels in 2023 (see Figure 5). The largest extra-EU export destinations for solar panels were Switzerland (31%) and the United Kingdom (25%).

#### What was the EU export value of solar panels in 2023?

The EU import values of solar panels and liquid biofuels in 2023 were much higher than the corresponding EU export values which were EUR0.9 billionfor solar panels and EUR2.2 billion for liquid biofuels. By contrast,the EU export value of wind turbines in 2023 (EUR2.0 billion) was much higher than the corresponding value for imports.

#### Does China export energy storage inverters?

The General Administration of Customs of China (GACC) recently released the import and export data for inverters in September 2023. In September 2023, the domestic exports of energy storage inverters amounted to \$650 million, marking a 33% year-on-year decrease and a 6% month-on-month decline.

#### What are China's solar PV exports?

In 2021,the value of China's solar PV exports was over USD 30 billion,almost 7% of China's trade surplus over the last five years. In addition,Chinese investments in Malaysia and Viet Nam also made these countries major exporters of PV products,accounting for around 10% and 5% respectively of their trade surpluses since 2017.

#### Why is Europe becoming a photovoltaic producer?
