

# Fire safety standards for energy storage systems

What are the safety requirements for electrical energy storage systems?

Electrical energy storage (EES) systems - Part 5-3. Safety requirements for electrochemical based EES systems considering initially non-anticipated modifications, partial replacement, changing application, relocation and loading reused battery.

#### What is fire safety standard?

Fire safety standard on best practices for fire alarm systems for buildings. Provides recommendations for all lifecycle stages of the buildings for ESS Explosive atmospheres - Equipment protection by pressurized room "p" and artificially ventilated room "v".

### What is a UL standard for energy storage safety?

Far-reaching standard for energy storage safety, setting out a safety analysis approach to assess H&S risks and enable determination of separation distances, ventilation requirements and fire protection strategies. References other UL standards such as UL 1973, as well as ASME codes for piping (B31) and pressure vessels (B &PV).

## What are the standards for battery energy storage systems (Bess)?

As the industry for battery energy storage systems (BESS) has grown, a broad range of H&S related standards have been developed. There are national and international standards, those adopted by the British Standards Institution (BSI) or published by International Electrotechnical Commission (IEC), CENELEC, ISO, etc.

#### What is battery energy storage fire prevention & mitigation?

In 2019, EPRI began the Battery Energy Storage Fire Prevention and Mitigation - Phase I research project, convened a group of experts, and conducted a series of energy storage site surveys and industry workshops to identify critical research and development (R&D) needs regarding battery safety.

### What is the NFPA 855 standard for stationary energy storage systems?

Setting up minimum separation from walls, openings, and other structural elements. The National Fire Protection Association NFPA 855 Standard for the Installation of Stationary Energy Storage Systems provides the minimum requirements for mitigating hazards associated with ESS of different battery types.
