When did Andritz Hydro acquire GE Energy?

In May and June 2008, Andritz acquired hydropower technology and certain assets of GE Energy's hydropower business (including test laboratories in Canada and Brazil), as well as GE Energy's majority interest in the joint venture GE Hydro Inepar do Brasil. Since January 2009, all these acquisitions now operate under "Andritz Hydro" name.
