## Italy energy storage costs

Does Italy need electricity storage?

As Italy's energy mix is increasingly composed of variable renewable energy sources, electricity storage will be needed to integrate power generated by renewables into the national grid and make it available when sun and wind energy are not accessible.

How will Italy invest in electricity storage?

Italy will promote investments in utility scale electricity storage to reach at least 70 GWh, and worth over Euro 17 bn, in the next ten years. The new storage capacity will be acquired through tenderspublished by Terna, the manager of Italy's high voltage grid. The next tender will be released in 2024.

Are energy storage systems becoming more popular in Italy?

Terna,the Italian TSO who monitors energy storage installation trends in Italy,has recently confirmed this growing demandfor storage systems. Terna have published statistics relating to the type and frequency of storage systems being constructed.

Are battery energy storage systems needed in Italy?

Therefore, battery energy storage systems (BESS) are needed in Italy. The Italian market for BESS is growing rapidly and currently amounts to 2.3 GW but it almost exclusively consists of residential scale systems, associated with small scale solar plants, having a capacity of less than 20 kWh.

How many storage systems are there in Italy?

More in detail,311,189 storage systemswere present in Italy in mid-2023,with a total power of 2,329 MW and a maximum capacity of 3,946 MWh. Terna (the high voltage grid operator) also holds systems totaling 60 MW in power and 250 MWh in capacity.

Are energy storage facilities regulated in Italy?

The Italian regulatory framework concerning energy storage facilities has been evolving rapidly in recent years. However, the legislation is relatively fragmented, given the high number of laws governing different aspects of energy storage facilities.
