Can lithium-ion batteries be stored indoors?

How do you store a lithium ion battery?

In general lithium-ion batteries should always be removed from the devices they power and stored at 60-70% of the pack's capacity. If a battery will go unused for three more days, it should be stored in a cabinet or larger store. Once disconnected, storing lithium-ion batteries follows similar principles as the correct storage of chemicals.

Can you store lithium ion batteries in the UK?

The UK doesn't have specific regulations or legislation for the general storage of lithium-ion batteries. The Health and Safety Executive has, however, published guidance on good practices for handling and storing batteries, even though it is not compulsory. Regulations are not prescriptive but instead follow the typical routes:

Do lithium batteries need to be discharged before storage?

Discharge as Recommended: Depending on the specific type of lithium battery, the recommended discharge level before storage may vary. Some batteries, such as lithium polymer (LiPo) batteries, should be stored at a partially discharged state (around 40-60% of capacity) to maintain their health during long periods of inactivity.

What temperature should a lithium battery be stored?

The ideal temperature range for lithium batteries is typically between 20°C and 25°C (68°F and 77°F). Avoid storing them in areas where the temperature can drop below freezing point. 5.
