

Who authorized Litgrid to synchronise the Lithuanian electricity system?

In the same year, the Government of the Republic of Lithuania authorized Litgrid to implement the actions of synchronisation of the Lithuanian electricity system with the Continental European Network. 2013

Does Litgrid have a partnership with PSE?

In May 2020, Litgrid and the Polish electricity transmission network operator PSE signed a cooperation agreement for the implementation phase of the Harmony Link connection project, in which the operators undertake to contribute in equal parts to the installation of the marine interconnection.

Where is the EU Delegation to Yemen based?

The EU Delegation to Yemen has been operating from Amman, Jordan, since 2017. EU's engagement with Yemen has expanded in recent years despite the challenging environment in the country. Several EU-funded projects have been launched and others scaled up to respond to the growing needs in the country.

How much does the EU support Yemen?

Since 2015, the EU's overall support for Yemen amounts to approximately EUR1 billion. The EU enjoys longstanding relations with Yemen, which date back to July 1998, when the relationship was formalised with the entry into force of a bilateral cooperation agreement focused on commercial, development and economic cooperation.

Does the EU support a political settlement in Yemen?

The EU remains very active at the political level, supporting the UN-led efforts and broadly advocating for an inclusive political settlement in Yemen in close coordination with the UN Special Envoy and his office (OSESFY).

How does the EU help Yemen?

The EU development cooperation broadly focuses on supporting rural resilience, early recovery, livelihoods, food security, primary healthcare, peace-building, economic inclusion, and small & medium-sized enterprises. Since 2015, the EU has provided EUR353.7 million in long-term assistance, becoming a leading development partner of Yemen.
