When do solar panels produce electricity in Ireland?

Solar photovoltaic systems generate electricity during daylight hours only, predominately around the middle of the day. In Ireland, around 75% is produced from May to September. If this electricity is not used in the home it is exported to the grid.

How does microgeneration work in Ireland?

Microgeneration involves installing a small generator powered by a renewable source such as wind, solar or hydropower, and connecting this to the electricity network. Solar photovoltaic systems generate electricity during daylight hours only, predominately around the middle of the day. In Ireland, around 75% is produced from May to September.

Do solar panels count as a micro-generator?

Solar panels are the most popular micro-generators and are more likely to provide the owner with excess energy. However, all renewable sources count if you can produce enough energy to export back to the grid. The Clean Export Guarantee (CEG) allows eligible customers with microgeneration systems to sell surplus electricity back to the grid.

How will Electric Ireland support customers on a low carbon journey?

Electric Ireland will support customers on their low carbon journey with the Microgeneration Support Schemes announced by the Irish Government on December 21, 2021. Microgeneration, such as solar photovoltaic (PV) panels, enables customers to generate their own renewable energy to reduce their carbon footprint as well as reduce electricity bills.

Who is eligible for microgeneration in Ireland?

Electric Ireland customers who own a micro-generator such as solar PV, micro-wind, micro-hydro, or renewable micro-CHP are eligible for this scheme. You must have an export grid connection, which is typically organised by the installer on installation or can be organised through ESB Networks. How can I avail of microgeneration?

4. Exemptions for wall-mounted and free-standing solar panel installations: free-standing solar panel installations for houses are exempted from the requirement to obtain planning permission subject to a 25 square metre area limit and conditions requiring a certain amount of private open space to be maintained for the use of occupants.

String warranties aren't as good, and if it breaks, your system is completely down. Whereas with micro-inverters if one breaks, your system will still produce. Also with the higher wattage micro-inverters, you can replace a panel if necessary with a higher wattage panel in the future and reuse the micro-inverters.

Q. How much can Electric Ireland customers save by applying for an SEAI grant to install solar PV? Grants of up to EUR2,400 are available through SEAI. That's EUR900 per kWp for the first 2kWp, EUR300 per kWp up to 4kWp. When you buy solar panels with Electric Ireland, our team will help to walk you through the process of applying for this grant.
