## New policy for solar power generation

What will changes to UK planning policy mean for solar power plants?

Co-written by Tom Edwards of Pinsent Masons. Proposed changes to UK planning policy remove uncertainty about the priority given to the development of major solar power plants and will spur a greater number of 'utility scale' projects in the years ahead.

Do you need planning permission to install solar panels?

Current rules that require businesses to apply for planning permissionif solar panels will generate more than one megawatt of electricity will also be scrapped, meaning organisations will be able to install more solar panels on rooftops without the delay and cost of applying for planning permission.

Can solar power help decarbonise the UK energy sector?

Does government support solar?

It sets out that government is supportive of solarthat is "co-located [footnote 80]with other functions (for example, agriculture, on shore wind generation, or storage) to maximise the efficiency of land use".

Will solar power increase global renewable power capacity by 2030?

Globally, solar PV alone accounted for three-quarters of renewable capacity additions worldwide. Prior to the COP28 climate change conference in Dubai, the International Energy Agency (IEA) urged governments to support five pillars for action by 2030, among them the goal of tripling global renewable power capacity.

Can solar projects be promoted under the NPS?

This has meant that, while utility scale solar projects have been able to be promoted under the NPS for energy infrastructure, developers have had to follow a more protracted route to gaining planning permission: developers have had to rely on the general policy support within EN-1 for their solar projects.
