Is mskvy a feeder level solar scheme?

Government's MSKVY scheme was launched on June 14, 2017 as a feeder level solar scheme. However, there are no studies on feeder level solar schemes in general and MSKVY to understand their impacts. For instance, Gujarat's state-wide SKY scheme encourages farmers to set up a grid-connected solar system in their fields and sell surplus solar energy to the grid.

What is mskvy scheme in Maharashtra?

It is a decentralized solar scheme where farmers are responsible for ensuring the safety and maintenance of their solar plants. In short, farmers derive benefits while maintaining status quo. The Maharashtra Government's MSKVY scheme was launched on June 14, 2017 as a feeder level solar scheme. However, there are no

How many MW solar projects can be interconnected with mskvy2?

Under MSKVY 2.0, up to 5 MW scale of solar projects can be interconnected with 11kV single circuit substations.

Should mskvy be in competition with large utilities?

MSKVY are decentralized systems of 2 to 20 MW meant to provide electricity to rural areas and should not be in competition with large utilities, as the latter have a huge advantage of scale.

How incoming solar power will be provided to substations in Maharashtra?

Government of Maharashtra would provide 'a one-time grant' of up to Rs. 25 Lac/Substation from Green Cess Fund for strengthening of identified substations of MSEDCL to accommodate projects under MSKVY 2.0. MSKVY 2.0 applies to the substations with mixed capacity.

MSKVY 2.0 shall be read in conjunction with each other, provided that only in the event of any conflict between the content(s) of the English version and the Marathi version of MSKVY 2.0, the Marathi version of MSKVY 2.0 shall prevail only to the extent of such conflict.
