Who owns Proterra battery solutions?

Proterra announced late last Thursday that Volvo Battery Solutions, an arm of international vehicle manufacturer Volvo, won a bid to purchase its Proterra Powered business line for \$210 million. That includes Proterra's battery-manufacturing, electric-drive train and vehicle-electrification business units.

What is a Proterra battery system?

"Proterra battery systems have been chosen by world-class OEMs to introduce 100% battery-electric vehicles, including delivery vans, electric school buses, coach buses, and low-floor cutaway shuttle buses.

Who owns Proterra powertrains?

The Proterra Powered powertrain manufacturing business line will operate as an independent company within the Volvo Group. The transit bus manufacturing business line was sold to Phoenix Motorcars. The Proterra Energy business line which built charging systems for fleets of heavy-duty vehicles was purchased by Cowen Equity.

Who is Proterra powered & energy?

"As an American technology leader, Proterra is proud to build on our strong relationship with LG Energy Solution to bring battery cell manufacturing to the United States," said Gareth Joyce, President of Proterra Powered & Energy.

What happened to Proterra powered?

The company filed for Chapter 11 bankruptcy in August 2023. In November, its assets were split into three divisions and sold off. The Proterra Powered powertrain manufacturing business line will operate as an independent company within the Volvo Group. The transit bus manufacturing business line was sold to Phoenix Motorcars.

Where are Proterra batteries made?

In November 2023, Proterra's battery business was acquired by Swedish truck maker Volvo for \$210 million. Proterra has its headquarters and a battery manufacturing facility in Burlingame, California, located in Silicon Valley. Batteries are also manufactured in Southern California's City of Industry.
