Does New Jersey have a competitive solar incentive program?

On December 7, 2022, the New Jersey Board of Public Utilities (Board) approved a notice of proposal to amend its existing solar energy rules to include the Competitive Solar Incentive (CSI) Program, to be codified at N.J.A.C. 14:8-11.10 as part of the larger Successor Solar Incentive (SuSI) Program, set forth at N.J.A.C. 14:8-11.

What is the New Jersey solar incentive program (Susi)?

By Board Order dated July 28, 2021, the New Jersey Board of Public Utilities (NJBPU) has established a new Successor Solar Incentive Program, also known as the "SuSI Program". The SuSI Program implements the Clean Energy Act of 2018 (L. 2018, c. 17) and the Solar Act of 2021 (L. 2021, c. 169).

What are the requirements for a community solar project in New Jersey?

Solar facilities must be connected to a distribution or transmission system owned or operated by a New Jersey public utility. All community solar projects must reach permission to operate on or before the expiration date noted in the CSEP acceptance letter.
