Is the US solar panel manufacturing industry injured by importing solar panels?

The U.S. International Trade Commission (USITC) today determined that there is a reasonable indication that the U.S. solar panel manufacturing industry is materially injured by imports of silicon solar cells and panels from Cambodia, Malaysia, Thailand and Vietnam.

What percentage of solar panels come from Vietnam?

Over 34 percent of solar photovoltaic (PV) modules imported into the U.S. between January and November 2023 came from Vietnam. In 2012, the Obama administration implemented duties on solar equipment imported from China to counteract the competitive edge held by foreign companies.

Are crystalline silicon photovoltaic cells antidumping or countervailing duty?

On May 15, 2024, the U.S. Department of Commerce (Commerce) announced the initiation of antidumping (AD) and countervailing duty (CVD) investigations of crystalline silicon photovoltaic cells, whether or not assembled into modules, from Cambodia, Malaysia, Thailand, and the Socialist Republic of Vietnam (Vietnam).

ALLEGED DUMPING RATES:

Are imports of solar cells injuring the US domestic industry?

The Petitioner asserts that imports of solar cells and modules from these countries, which represented nearly 80% of U.S. imports of solar cells and modules in 2023, are injuring the U.S. domestic industry because they are sold in the United States for "less than normal value" (i.e., dumped) and unfairly subsidized.

Can I import solar cells from Cambodia?

Imports of solar cells and modules from Cambodia, Malaysia, Thailand, and Vietnam will not be subject to suspension of liquidation or cash deposit requirements if accompanied by a certification attesting that they are not circumventing the ADD/CVD orders. There are three types of certifications:

Are crystalline silicon photovoltaic cells subsidized by Cambodia?

The USITC also determined that there is a reasonable indication that a U.S. industry is threatened with material injury by reason of Crystalline Silicon Photovoltaic Cells, Whether or Not Assembled into Modules, from Cambodia that are allegedly subsidized by the government of Cambodia.
